

Therefore, please design heat release of a device with due consideration to the temperature rise of IGBT.






Fig. 7.1 Marking




Fig. 8.1 Ic - VCE




Fig. 8.3 I_C - V_{CE}




Fig. 8.5 V_{CE(sat)} - T_c




Fig. 8.2 I_C - V_{CE}




Fig. 8.4 I_C - V_{CE}




Fig. 8.6 I_C - V_{GE}






Fig. 8.7 Switching Time - I_C




Fig. 8.8 Switching Time - R_G




Fig. 8.9 V_{CE}, V_{GE} - Q_g




Fig. 8.10 C-V_{CE}




Fig. 8.11 Safe Operating Area (Guaranteed Maximum)




Fig. 8.12 $r_{th(j-c)}$ - t_w (Guaranteed Maximum)






Fig. 8.13 Reverse Bias SOA (Guaranteed Maximum)




Fig. 8.14 I_F - V_F




Fig. 8.15 I_{rr}, t_{rr} - di/dt





Fig. 8.16 I_{rr}, t_{rr} - I_F
