#### 1. Functional Description

· Quad 2-Input NAND Gate

#### 2. General

The TC74AC00P is an advanced high speed CMOS 2-INPUT NAND GATE fabricated with silicon gate and double-layer metal wiring C2MOS technology.

It achieves the high speed operation similar to equivalent Bipolar Schottky TTL while maintaining the CMOS low power dissipation.


The internal circuit is composed of 3 stages including buffer output, which provide high noise immunity and stable output.

All inputs are equipped with protection circuits against static discharge or transient excess voltage.

#### 3. Features


- (1) High speed:  $t_{pd} = 3.8 \text{ ns}$  (typ.)  $V_{CC} = 5.0 \text{ V}$
- (2) Low power dissipation:  $I_{CC} = 4.0 \mu A \text{ (max) } T_a = 25 \text{ °C}$
- (3) High noise immunity:  $V_{NIH} = V_{NIL} = 28 \% V_{CC}$  (min)
- (4) Output current:  $|I_{OH}|/I_{OL} = 24$  mA (min) ( $V_{CC} = 4.5$  V)
- (5) Balanced propagation delays:  $t_{PLH} \approx t_{PHL}$
- (6) Wide operating voltage range:  $V_{CC(opr)} = 2.0 \text{ V}$  to 5.5 V
- (7) Pin and function compatible with 74F00.







#### 5. Pin Assignment


